



As it stands now, Mr. Sam Nugent, Cubmaster for Cub Pack 9, Hays Manor, McKees Rocks, PA has been charged with Rape and Indecent Assualt, and Corrupting the Morals of a Minor (They being and arrest warrant out for Mr. Nugent. A search warrant states that the acts occurred during a period of about two years (1986 to present).

According to the police, 90°/o of the acts were done in the apartment of Sam Nugent and 10°/o occurred at the residence. It is alleged that Mr. Nugent called the victims into his bedroom and encouraged them to undress.

Denald A Partice was called at his home on Monday, January 2, 1989 by mothers of the children, stating that Sam had been exually molesting:

has stated that Sam Nugent forced him to have anal sex with him.

stated that Sam Nugent performed oral sex and anal sex with him
and forced him to perform oral sex with Sam Nugent.

perform sexual acts. The first of these acts were to have occurred in the beginning of 1986 and the last was said to have occurred on December 21, 1988.

A search warrant was sworn out immediatly for Mr. Nugent's apartment.

On Tuesday, January 3, 1989 at 2:15PM, Lt. Panyko and five plain clothes detectives for the Allegheny County Police entered the Nugent apartment in search of PlayBoy Magazines and a black male organ vibrator used for anal intercourse. The police found handcuffs, a billy club, and PentHouse Magazines. They left everything in the apartment. (This statement is a combination of an interview with the Housing Manager and Lt. Panyko.)

The following Cub Scouts and parents were interviewed concerning Mr. Nugent and if they had ever been approached by Mr. Nugent.

ich scout had stated to Lt. Panyko that they had NO involvement with Mr. 'ugent in this manner. Lt. Panyko will continue to interview the scouts id parents. (Attached is a list of those scouts.)

Mr. Sam Nugent has been thought to have entered the West Penn Hospital in the Psychiatric Section. The hospital will not confirm this statement to the police. They will confirm however that he has been admitted to the hospital. His lawyer has stated that after he is released from the hospital over the weekend, Mr. Nugent will turn himself into the McKees Rocks Police.

It has been established at this time the NO DRUGS or ALCOHOL were involved. (This could change after more investigation.)

I had learned about thie incident from Pat Mason, Social worker for the Public Housing Improvement program, Action Housing, Inc. Actio Housing now holds the charter after it was given over by the Tenat Council President, Odean Banks in September, 1988. (Mr. Nugent became the Cubmaster in the Spring of 1988.) The letter turning the charter over to Action Housing is attached.

In my working with Mr. Nugent, I found him to be a positive influence on the scouts. He is not the most typical of role models however. He wears his hair in a ponytail and also wears an earring. Much of this I understood being part of his nature and a standard for anyone in this particular cousing Project.

Mr. Nugent, is registered with the unit as a Den Leader. She is the wife of the Mr. The Assistant Cubmaster for Pack 9. A Mr. Keith Gary is listed as the Cubmaster for the unit on the current charter. This was changed by the Unit Committee to have to as the Cubmaster after it was learned that Mr. Gary had a history of alcoholism among other things. Mr. Nugent was then recruited by to become the Cubmaster only after Rizzo felt he could not handle the position. Mr. Rizzo has not been implicated in this investigation concerning Mr. Nugent. It was suggested by the police that we also closely examine the records of Mr. Rizzo about his past involvement with drugs.

Nugent is also registered as being part of the District Camping Committee in the Three Rivers District. His involvement on that committee was not extremely active (according the Mr. Nugent in a conversation with me in the past.) He may also serve in a unit in the district also. (He eluded to this in a conversation also.) Mr. Nugent also may be known by some as Sam Henon.

To say the least, Mr. Nugent is not a popular with some of the residents of Hays Manor. Now, more than ever. I hope that the program would not end in this community. Although, because of this situation, our credibility in this community has suffered a severe blow. I will proceed with whatever action you judge as fit for this situation.
