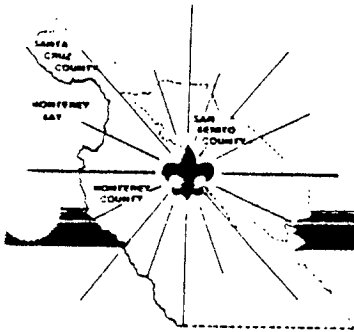

3. My right to see, hear and question all witnesses against me and to have witnesses summoned on my behalf.
4. My right to remain silent.

I also understand that if I enter a plea of guilty or no contest, I could possibly be sentenced to:

Serve up to one year in the Monterey County Jail or,  
Fined up to \$10,000.00 plus assessment penalties or,

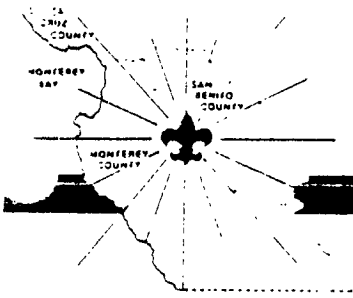

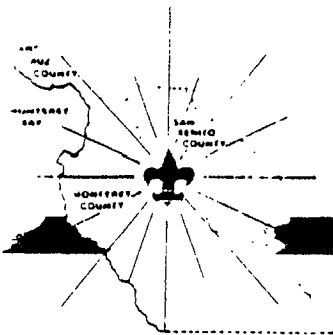
