

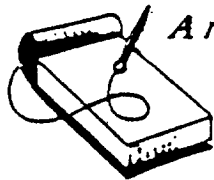

Scout leader charged in incident with minor

A Raleigh man whom police described as a Boy Scout leader has been charged with taking indecent liberties with a minor.

Terry Dawson Hardin, 31, of 6116 New Market Way also was charged with committing a crime against nature, according to an arrest warrant on file in the Wake Courthouse. Police said the victim was a 15-year-old boy who had been a Scout. A spokesman for the Occaneechee Council of the Boy Scouts of America declined to comment Friday on Mr. Hardin's arrest. Raleigh Police Sgt. C.E. Lewis said investigators think that the crimes occurred over the past year, and that the suspect and the victim knew each other through the Scout program.

Mr. Hardin was ordered to have no contact with the youth, according to the warrant. He was released from custody Thursday and signed a written promise to appear in court Friday.


Dear Mr. Hardin:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are enclosed.
