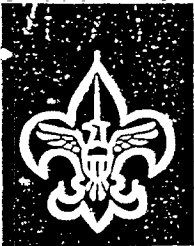

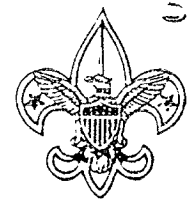

September 14, 1987

On Wednesday, May 13, 1987 at 9:00 PM, I received a long distance phone call from Joel Hamlett of Snyder, Texas. Joel Hamlett is an assistant Scoutmaster with Troop 27 in Snyder.

Mr. Hamlett advised at that time that Terry Rumpff, [REDACTED] Snyder, had been arrested the previous evening, May 12, 1987. Mr. Rumpff was also serving as an assistant Scoutmaster with Troop 27. Mr. Hamlett stated that Mr. Rumpff had been arrested in Snyder and that the charge had something to do with a morales charge.

At 9:05 PM, 5-13-87, I called Gerald Petty at his home and passed this information on to him.

On May 14, 1987, I traveled to Snyder and went to the district attorney's office to see what information could be obtained and if in fact this individual had been arrested. I visited with Ernie Armstrong, the Scurry County District Attorney in his office.

Mr. Armstrong did state that Terry Rumpff had in fact been arrested and yes, the arrest was in reference to a morales charge. After explaining to Mr. Armstrong the Boy Scouts of Americas position, he opened up and gave the following information:

Terry Rumpff had been arrested on a charge of "Indecency with a Minor".

Mr. Armstrong further stated that Mr. Rumpff would more than likely have a second charge of "Aggravated Sexual Assault filed against him".

Mr. Armstrong stated that he wished to point out that if both parties in this case had been adults that it would have amounted to consenting adults. Mr. Armstrong advised that there was no force of any kind used or implied. That their actions had involved mutual consent, but due to the fact that one of the participants was a minor, the charge of aggravated sexual assault was filed against the adult.

Mr. Armstrong advised that the minor involved (he would not name him) and his mother brought the matter to him.

That was basically what was disclosed to me by Mr. Armstrong.

Mr. Rumpff was out of jail on bail for most of the summer.

On 9-9-87 I visited [redacted] with a Scouter in Snyder, Doc [redacted]. Griffin, who stated that he had, the previous week, visited Terry Rumpff in the county jail with Terry's parents. Terry Rumpff had been indicted and was now in jail.

Doc R. Griffin further stated that Terry had informed him that his attorney was in the process of plea bargaining on the case.

This is the only information that I have been able to obtain at this point.

It is with great sorrow that I write you ~~this~~ this letter of resignation. But I must. I have had the criminal charge of Indecency with a child pressed against me, and due to this terrible fact I ~~must~~ feel that I must entirely retire from the scouting program. If my name is cleared then I may try to return. However, after talking to my lawyer, I feel that it is highly unlikely. I'm terribly sorry, and I hope that you can find someone else to take my place. Please Pray for me.
