If you find evidence of any other situations which would help to strengthen our file, please send them to me so that the file will be complete in case neither of us are on our present job when this individual tries again to register.


Thanks again for the complete record which you have sent. We would also like to have information if it is decided that any legal action is to be taken against Mr. Lewis.

My son, was invited by Tommy Lewis to spend the night after our Church's Christmas program which was held on Sunday, December 19, 1982. Tommy informed that several of friends from school were coming and they planned to have a party. Asked our permission and, as usual, we asked who was going to be there and be said Tommy told him and and others. Therefore, we gave our permission.

On the morning of December 20, 1982 at approximately 3:45 a.m., called home and asked me to pick him up. I asked what was the matter, and he said he wanted to come home. I, again, asked what was wrong, and he said he did not feel good and to please come and get him. I knew, from the tone in his voice, there was something else wrong, but felt I should get up and go get him right away. I told my husband, about the phone call and he immediately got up and we both went to pick up when we arrived, he right away came out of Tommy's apartment and when he got in the car, he started crying. We asked him what was the matter and he said he just wanted to go hom. However, we told him we could not leave until he told us what was the problem. The related in detail that Tommy Lewis had come to the couch where he was sleeping and made bomosexual advances toward him.

When finished relating what had happened, we turned around and went back to Tommy's apartment and confronted him with accusation. He admitted what he did and said he was sorry and that he was sick. We left and started to go out and take a warrant, but decided to talk to our minister first. After relating the happening again, Mr. Morrison, our minister, suggested that we call J. B. Allen, Chief District Court Judge, member of our church, Emmanuel United Methodist Church, and a friend of our family. He came to the parsonage right away and once again related what happened.

It was agreed that J. B. Allen and Rev. Morrison would meet with Tommy that morning at 8:30 in the church's study. Later we were informed that morning and he admitted to both of them what he had done.

Since that time, has had a very hard time dealing with what happened and has had nightmares, guilt feelings and I guess embarassment. I know that in time, he might be able to cope with this, but will not forget in a very long time.

She informed me that her son, was not in Scouting, but that the volunteer in question was coming in contact with alot of boys in Scouting and in the church. She proceeded to tell the story that her son had told her. This is her story as per our conversation.

On Sunday night, December 19, 1982 was invited to the home of Tommy Lewis and told that several of his friends from church would be there also. Supplied to go after evening church services with Mr. Lewis to his home, to find out that no one else was going to be there. At bedtime was going to sleep on the couch. During the night, was awakened by Mr. Lewis rubbing him on his back. At this point Mr. Lewis told he could not sleep on the couch, so why didn't he come get in bed with him. Upon doing this, was surprised when Mr. Lewis proceeded to take off underwear. Mr. Lewis then proceeded to touch private parts and pull close to him and tried to kiss him.

At this point called home and asked his parents to come and get him.


A citation accompanying the award said:
