Dear Howard:

As a new executive in this council I uncover a mystery now and then. As you can see by the enclosed the duplicated copy of the troop charter application shows Thomas Hodges paying as Scoutmaster--yet, when I refer to the transmittal I discover that his registration was not paid, and that his registration was changed to "multiple". Both office girls were new at the time and can throw no light on the reason for the change- the route sheet used at that time gives no answer- so, frankly, Tom Hodges is not registered, so far as I can discover!

I had a call from an irate father of a Cub Scout advising me that his son had told him of certain homosexual activities engaged in with him by Hodges. I asked him to find out from his son, if possible, if others were involved and when later advised that there were two other fathers ready to testify, Tom Burgess (who happened to be in the council) and I called on this father (who is registered as a member of the district finance committee) and together we decided upon a plan of action. We (Tom and I) contacted the head of the institution, the pastor of the Christian Church and advised him of the necessity to replace Hodges. As he had a son in the pack he called the institutional representative and together they made an appointment for that evening with Hodges. They took along an attorney, a member of the committee, to sit in on the meeting. Hodges admitted his guilt and immediately resigned, without "fuss or fanfare". I believe the committee was more surprised than we were.

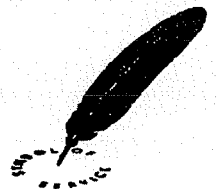
I have completed the record sheet to the best of my ability and also enclose it.

This is my first experience with something like this in twenty years of professional Scouting!

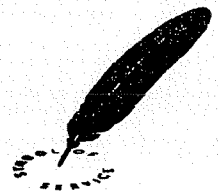

Dear Mr. Nexsen:

Your recent letter to Mr. Wilson has been referred to me because it is in Registration Service that all matters for the confidential file are handled.

You refer to us the name of Thomas D. Hodges and indicate that he is to be separated from both Troop 155 and Pack 156 of Winder. We have taken this action.

There are, however, two or three items which need further clarification. First, our records indicate that Mr. Hodges' registration in both the Troop and the Pack is in a multiple position and that he has paid elsewhere, but neither the Troop or the Pack show in what other capacity he has paid his registration fee. Please advise us where he has paid. Second, you indicate that Mr. Hodges is to be separated but you do not give us any reason. From the tone of your letter I have my suspicions but we must have facts. Why are you placing him on the confidential file? For what reason? Specifically, what happened? What did he do? We do need this information in order to have substantiation in our files for the action being taken. Finally, to help us with future identification, we need to have as much information as possible concerning this individual. We are, therefore, enclosing a confidential record sheet which we would appreciate your filling in and returning to us as soon as possible giving us as much information as you have available. This information helps with identification should Mr. Hodges ever again attempt to register in the Scouting program.
