August 6, 1990

This is a follow-up letter in response to the reports incident involving Tom Stamps and [REDACTED] on the evening of Thursday, July 26, 1990.

On the morning of Friday, July 27, 1990 I was approached by Samuel Phillips, Camp staff (wrangler), who reports that he needed to tell me of a possible child molestation involving an older staff member and [REDACTED]. He said [REDACTED] had told him that Tom Stamps had gotten him [REDACTED] drunk and had tried to grab his crotch area several times. [REDACTED] had asked Sam not to tell anyone except myself I told Sam to not discuss this with anyone & that I would take care of the situation.

I reported the incident to Frank Mund and was advised to try to talk with [REDACTED] and get a side of the story. I asked my wife [REDACTED] to go with me to talk with [REDACTED] because [REDACTED] was his immediate supervisor for two weeks, and she felt he might confide in her.

That afternoon, we asked [redacted] to go with us to the maintenance yard to help me with a project.

[redacted] took [redacted] aside and asked him about the incident. [redacted] reported to her that Tom bought a twelve pack of beer, and [redacted] drank one and didn't like it. Tom then asked him what he wanted to drink and then bought some wine coolers. [redacted] didn't remember how many he drank. Then then we went to the Point at Canyon Lake where [redacted] reported they fell asleep and woke up to return to Camp @ 1:30 A.M. [redacted] reported they went to the Health Lodge because Tom said they were too drunk to go to Staff site. At the Health Lodge, they woke Bill Thoms up who then went back to the staff site. [redacted] and Tom both laid on the bed at the Lodge and [redacted] reported that Tom kept touching him in his groin area. [redacted] reported that he removed Tom's hand several times Tom asked several times if [redacted] was awake, but [redacted] reported that he just ignored him. [redacted] reported that Tom kept touching him. I then got [redacted] and [redacted] to ride back with me to Klanshee Road and I asked [redacted]

[REDACTED] how much he had to drink and he reported he drank one beer and three wine coolers (he tho I asked him if Tom touched him while they were at the point, and [REDACTED] said No. I asked him to tell me about when he and Tom were in the Health Lodge, and [REDACTED] reported that Tom may have "accidentally touched" him in the grain area. I asked him to show me & he put his hands on his thigh area several times on his own leg.* This is mostly what [REDACTED] reported to [REDACTED] and myself that afternoon.

* [REDACTED] also reported that he didn't think Tom was that kind of a person.

Aug. 6, 1990

This is a recap report on my two conversations with [REDACTED] the father of [REDACTED]

My first conversation with [REDACTED] happened when [REDACTED] arrived to pick [REDACTED] up from work on the staff at Horseshoe Bend, and to drop his other son off for Boots and Saddles. I asked [REDACTED] to join me in the Heath Lodge, and I told him [REDACTED] had gone out drinking with Tom Stamp. I told him [REDACTED] had admitted getting drunk. [REDACTED] did not appear to be upset except for the fact that [REDACTED] had been riding in a vehicle with an intoxicated driver. I told him that Tom Stamp had resigned and left Friday night. I told [REDACTED] that [REDACTED] had been doing a good job and would be invited back next summer if he desired to return.

My second conversation with [REDACTED] occurred at the corral when [REDACTED] returned to pick up his son from Boots and Saddles. He expressed a deep concern over what [REDACTED] had told him about the incident. I explained to him that I had not previously told him the full story because my supervisors and I agreed that it might not be time to do so. He asked if it had been reported Houston, and I told him I had written an incident report and sent it to Roger Chmstede and Steve Leland that previous Saturday. He wanted me to call Steve Leland and let Steve know that he would be there Monday. I told [REDACTED] that I had told [REDACTED] that he needed to talk to someone about the incident. [REDACTED] reported that [REDACTED] had been acting "different" all week and finally confided in him on Friday evening about the incident. [REDACTED] said he wanted to follow up on the incident and make sure that Tom Stamps would not be allowed to stay in Scouting and that he wanted to make sure the incident was [REDACTED]

type incidents were hard to prove, but that as far as he was concerned Tom was guilty. He just wanted to make sure that Tom was not allowed to stay in Scouting. [REDACTED] said he wasn't angry with me or the way things were handled, but if he ever saw Tom again he might "Flash".

[REDACTED] was very polite and understanding but was quite concerned for his son and the welfare of others. He did say that if I had told him the first Saturday when he had come to pick up [REDACTED], he probably would have been much more upset.

Dear Mr. Stamps:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.
