Reference is made to your inquiry of 25 September 1969 and your request for a copy of the voluntary statement made by Bradford, after his arrest for Public Lewdness on 24 September 1969.

Thomas W. Bradford, 18 Birchgrove Drive, Central Islip, age 22, did make a voluntary statement admitting to repeated acts of public lewdness. Our records also disclosed a previous arrest on 25 August, 1969 for the same offense. We cannot supply you with a copy of his statement, because it is official evidence. However, this letter is intended to attest to its existence.

Should you proceed to have Bradford "barred" from Scouting, you are authorized to use this letter and any other further confirmation can be made by official inquiry.

Dear Sir,

On the night of Wednesday, 13 of August, 1969, a man aged 22, named Thomas Bradford lured my son, [REDACTED] and two friends named [REDACTED] and [REDACTED] from our back yard tent. The time was approximately 12 a.m. They met at 7-11 deli and picked up another young boy, [REDACTED]. They boy rided around Brentwood. The [REDACTED] boy was reported missing from home to the police. A phone call to my house at approximately 1:15 a.m. inquiring of the [REDACTED] boy woke me and I looked in the tent for my son. Not finding him or his friends my wife and myself drove around to [REDACTED]'s house. He had just returned home. We told us our son [REDACTED] and [REDACTED] and [REDACTED] were still in Bradford's car. We went looking for them and found them coming from behind a warehouse on Grand Boulevard and Alkier Street. It was now 2:00 a.m. We stopped the car and ordered the boys out. I demanded identification from Bradford, he reluctantly showed me his drivers licence. In the morning around 8 o'clock, after questioning my son and his friend, I took both of them down to police headquarters. They were questioned by detectives and it was further learned that they stole five gallons of gas. This is why they were coming from behind the factory warehouse when I caught up with them.

The police went looking for him and located him at a lake on Sunrise Highway. When he was picked up he was nude except for a towel wrapped around him. When I was informed of his attire at the time of his apprehension, I questioned my boys further. I learned that on three different occasions my boy snuck out of the back yard tent and met with this man. On one occasion both of my sons, [REDACTED] 12, [REDACTED] 14, and [REDACTED] slept overnight in the woods in Central Islip known as Johnson's Woods.

This was all done without my knowledge. Thomas Bradford passed himself off so my wife as being [REDACTED]'s older brother just home from Viet Nam and eager to take his young brother and his friends fishing and swimming. Now I learn that this man went swimming nude in front of my boys.

Every day since this August 13, meeting I find out more and more about him. He passed himself off to Mrs. [REDACTED] as one Thomas Peliciano. Another family was told that he was my oldest daughter's ex-boyfriend. She is now living in North Carolina and has never met or heard of this man.

Although this man is not under arrest as yet, he did make a statement at Police Headquarters. After being released from the police station and being warned to stay away from all boys concerned he returned immediately to [REDACTED]'s neighborhood and again approached her son and [REDACTED].

This man is definitely not an asset to the Boy Scouts of America, and I am hoping that something can be done to relieve him of his duties in the Scouts. He is affiliated with Troop 271 or 71 of Central Islip.

I have already told the police that I would write to you and they told me I should.

Any further information to bear out my sad tale maybe obtained at the Police Station. It is located at 5th Avenue in Bayshore. The phone number is FO 5-8780. The detective is Mr. Lee Heiser.
