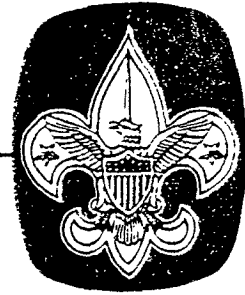

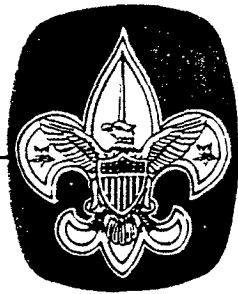

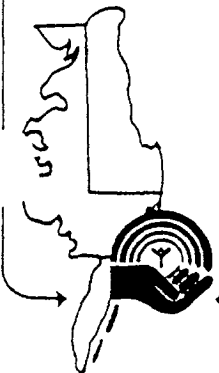

On September 18, 1987 at 9:00 a.m. I returned a phone call to [REDACTED], Cubmaster of Pack 92. She informed me of her intent to have Mr. William Zimmerman, former Cubmaster of Pack 92 arrested.

She told me that Mr. Zimmerman had sexually touched and fondled her son on several occasions. She did however say that these events did not take place at any Cub Scout function, and to her knowledge were not done to any other child.

She said the point of her phone call was to make us aware of the situation, and to let us know that Mr. Zimmerman was now in Florida, and may be interested in Scouting there.
