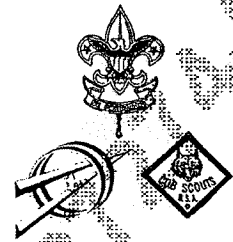



Gentlemen:

On February 15, 1967, several boys from Troup 65 participated in a Patrol camp out. The parents were told that all boys of this Patrol would be given an opportunity to advance to their next rank or to complete as many requirements as possible.

My two sons, [REDACTED], age 12, and [REDACTED], age 11, were among the boys in this group, under the leadership of Assistant Scout Master William E. Stone, Jr.

At bedtime, the boys were told that they would be taught how to keep warm on a winter camp out. They were told to remove their outer clothing and to get in bed with Mr. Stone. These boys had been on previous winter camps and were prepared for the cold with heavy clothing and sleeping bags.

Mr. Stone proceeded to call the boys to him individually and rubbed and caressed their bodies. These boys were embarrassed, frightened and repelled by this treatment.

My son [REDACTED] was the youngest of the group and the last one to be approached. He was in his sleeping bag at the far side of the tent. Mr. Stone pulled his sleeping bag across the tent and unzipped it and proceeded to caress [REDACTED] and forced [REDACTED] to caress him. When [REDACTED] tried to draw away, Mr. Stone restrained him by holding him with his arm around him.

As a parent, I feel that this man is not a wholesome influence and that it is not in the best interest of Scouting to have him associated with the Boy Scout program.

Gentlemen:

This is to advise that on Friday, February 24, 1967, the Seal Patrol of Boy Scout Troop 65, of which my eleven year old son, [REDACTED], is a member, was taken on an overnight camping trip by William E. (Bill) Stone, Jr., one of the troop leaders.

Upon returning home, my son told me of Mr. Stone making the boys strip to their underclothes before getting into their sleeping bags. He told me that Mr. Stone called him to come to his sleeping bag and that Mr. Stone began to hug him and rub him below the waist and on the private part of his body.

[REDACTED] became afraid, due to his lack of knowledge of this sort of conduct, and pretended to go to sleep. Mr. Stone told him to go back to his sleeping bag and proceeded to call other younger boys to him.

Mr. Stone did not allow the boys to fix breakfast until 10:30 on Saturday, and lunch was prepared at 3:45. Mr. Stone made [REDACTED] open his sleeping bag outside the tent, laid himself upon it, and proceeded to make the boys rub his back and shoulders. His actions were such that the boys hunted excuses to leave the camp area and hide in the brush to avoid him.

I was told by Mr. Stone on Friday that the boys would be returned by 5:00 Saturday afternoon. They returned at 6:15 because they had not spent enough time on their prescribed work!

Upon hearing of all the incidents which transpired on the camp-out, I contacted the father of one of the other boys. We then met with the troop leaders. We have decided that this action be taken to notify you of the moral conduct of Mr. Stone.

We are writing this letter to report the immoral behavior of Mr. William E. Stone Jr. on a Boy Scout camp out.

On Feb. 24, 1967 Mr. Stone took six members of the Sea Patrol of Troop 65 to Vidor Texas for an overnight camp out. That night he had our son, ██████████, come to his bed and remove all his clothes and get in his bed. ██████████ said, "Daddy, he put his hands all over me." ██████████ was asked if Mr. Stone put his hands between his legs and played with his private parts. ██████████ answered, "Yes Daddy, he did and he had me put my hands on him." ██████████ said when Mr. Stone sent him back to his bed, he told the boys hear him not to go near Mr. Stone because of what he did.

The next day Mr. Stone had ██████████ and three other boys take turns rubbing his back. They were afraid not to because of his strange and unusual behavior.

Mr. Stone has proven to us that he is unfit to work in scouting in any capacity. He does not measure up to the standards of Boy Scouts.

We will be happy to cooperate with you in any way we can.
