- 1. Met Bill at NOAC 1983 (August) in New Jersey. Bill traveled with contingency.
- 2. Bill asked for volunteers to help with video equipment. helped with video equipment.
- 3. Bill tried to hypnotize and other boys, but could not hypnotize them. Said adult advisor said not to do it.
- 4. When picked up after returning from NOAC, Bill asked him if tould help with taping, splicing of video.
- 5. During September 1983 make-up ordeal at Pueblo, Bill again asked for help with video splicing at his house. Stayed for the weekend at his house.
- 6. Although doesn't remember exact date, but just after ordeal, rode in city bus with Bill all day then spent night with Bill. At house, Bill showed a movie "a little more than graphic." Just and Bill.
 - 7. Easter of 1984: got scared showed movies of two guys in sexual acts. Could have left but felt he needed to stay. There were other people, about 17 at time), (16 or 17), next door neighbor. Bill gave other two massages, with clothes on, putting hands where they shouldn't have been. The two guys took showers there, were walking around in just towels. Took him to golf games etc.
 - 8. A little after that, told a friend (a year older than to go with
 - 9. When and friend got to Bill's, was completely unclothed. and friend were embarrassed. Bill asked them to stay, went into other room for long time. Bill offered beer along with Bacardi and coke, started drinking. At least 2 or 3 were under 21 that weekend.
- started showering over there. Bill said he had clothes for him. As got out of shower once, Bill handed him a shirt to try on, tried it on and Bill took Polaroid pictures of him; shirt was unbuttoned, no other clothes on, could see all his body. said he saw a lot of other pictures taken at Bill's house (could see Bill's house, etc. in background). Boys (some) looked younger, Bill said they were kids from old Troop; "stack about this high" (8 to 12 inches). All boys unclothed. Single boys only.

- 11. Another time, Bill asked to make a movie, hinted with clothes off.
- 12. Another time after that, which had gone to Bill's house and saw a movie Bill had made of friend. Just Bill and friend were there, friend was unclothed. A second young male was in movie, they were touching each other in private areas. Bill said next time and his friend came over, they could make a movie like that.
- 13. 1984 end of summer 16 years old: was at Bill's house, stayed up to watch HBO late movies, just Bill and they went to bed, in guest room, Bill was in own room. Was in bed for about 20 minutes, Bill came in, sat on bed, said wanted to talk. Said he couldn't get to sleep, Bill said he would give shoulder massage and did, then moved his hands to private area, the felt uneasy, tried to turn away, Bill started running a comb across buttocks, said to stop, Bill tied hands together in front of him with dog chain, it was hurting, tried to get hands out, it was hurting, couldn't get hands out; was done playfully at first then got scared (Bill large man), Bill continued to scratch his buttocks with comb, said stop, Bill did not. Eventually, Bill stopped, untied him, nothing happened after that.
- 14. Bill called, trying to talk to tried to avoid him.
- 15. One time Bill talked to on phone, after friend ran away, said that if he went to jail, that he would pay; friend would get them.

Gary Nusbaum and I met in private in my office. I told him of the statement that had been made by concerning his allegations of Mr. Challberg's actions. I did not use name, but I assured Gary the boy was not a member of Post 522. I told Gary that while we were not charging that Bill Challberg did molest this boy, we were acting on the statement and felt it would be in the best interest of all concerned if Mr. Challberg was removed from a leadership position in Scouting.

Gary Nushaum told me he had "heard stories" about Mr. Challberg and had told him that if he ever caught him or heard of any problems, he would have to leave the Post.

We agreed that Gary would meet with members of his Post Committee and they would then meet with Mr. Challberg and tell him he was not longer associated with Post 522. I offered my assistance, in any way, concerning the matter.

We agreed this would happen by the end of April and that Gary Nusbaum would inform me when the removal was over, so F could take proper action with the National Council.
