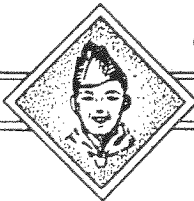

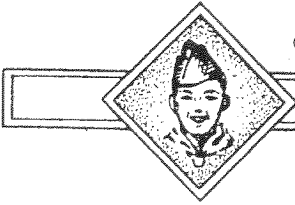

Local Scoutmaster Arraigned On Four Morals Complaints

TOMS RIVER — William R. Pratt, Sulton Place, was arraigned yesterday on morals charges before Dover Township Magistrate Benjamin Novins.

The 31-year-old beautician waived hearing in magistrate's court and was held over for Grand Jury action under \$10,000 bail.

Pratt, who has served as scoutmaster of Boy Scout Troop 207, was charged with the following offenses by Dover Township Detective John Hayes:

Contributing to the delinquency of minors.

Possession of indecent literature, suborning to unnatural sex acts tending to impair the morals of a minor.

Having unnatural sex relations with minors.

The scoutmaster was charged with the offenses last week following a three-week investigation by Detective Hayes.

Man 30, is Held
For Grand Jury!

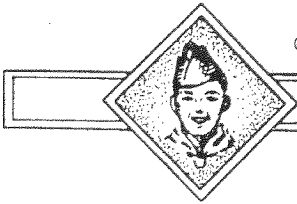
TOMS RIVER — William R. Pratt, 30, of 26 Sutton Pl., Silver Ridge Estates, has been held for Grand Jury action by Magistrate Benjamin Novins. He was released under \$10,000 bail, police said.

Four charges were filed against him. Detective John Hayes, investigating officer, said. Also assisting in the case were Police Capt. Richard C. Clement and Patrolman Peter Chafatelli.

Charges include contributing to the delinquency of minors; possession of pornographic literature, and unnatural sex acts with 14 and 15-year-old boys.

Pratt was under surveillance for month before he was arrested last week.

Dear Basil:

Mr. Pratt was arraigned before the Municipal Court at 1 p.m. on October 18th, 1961. He was represented by a lawyer.

Four charges were held against him:

- a. Contributing to the delinquency of a minor
- b. Possession of indecent books, papers, articles, pictures, etc.
- c. Submitting to unnatural sex acts impairing minors
- d. Unnatural sex relations with a minor

Mr. Pratt's lawyer waived reading of the complaints and hearing and agreed with the court that the matter be held for Grand Jury. Bail amounted to \$10,000 and was continued.

DET. HAYES I AM GOING TO ASK YOU SOME QUESTIONS CONCERNING A MR. WILLIAM PRATT. ARE YOU WILLING TO ANSWER SAME ?
A. YES.

Q. How long did you know him, and how did you meet him?
A. About the middle of summer. One of my friends a [REDACTED] told him about me, and he asked me to join the scouts.

Q. After you got to know him, did you ever go to his house ?
A. Yes, and after I got to know him, it was often.

Q. Was he your scout master ?
A. Yes.

Q. Did he ever make any advances to you, or did he ever talk about sex to you ?
A. Yes he did make advances and he did talk about sex. It happened numerous times.

Q. What did these advances consist of ?
A. He would grab my privates.

Q. Did you ever see him grab any one else ?
A. Yes, I seen him grab [REDACTED] and [REDACTED]

Q. Will you tell me about the overnight trip ?
A. We were going on a overnight trip with Scout Master Pratt. He stopped at the Hub on Main st. Toms River, and he went inside to buy some beer, we boys, [REDACTED], [REDACTED], [REDACTED], myself went to buy some ice for the soda we had on hand. When Mr. Pratt came back we put the beer on ice. Some was drank on the way down and rest was drank at the camp site.

Q. Did you ever see any thing pertaining to sex in his house ?
A. Yes.

Q. What was it ?
A. Magazines, books, pictures on the wall, and a statue of a nude man in his bedroom. On one occasion we were looking at magazines in his house, and he was looking at a nudist type magazine, he came over to me and showed me the naked females. He said " take a look at this ".

Q. What did his talks about sex consist of ?
A. He told me about the french tickler. And if I was reading a magazine, he would say, " Are you excited" He had one expression he often said, and it is as follows; " How is it hanging".

Det. Hayes The above statement is true to the best of your knowledge and is given with no threats and or promises from the police. After you have read it, would you be willing to sign it ?

A. Yes.

DET. HAYES Q. I am going to ask you some questions concerning your knowledge of Mr. Pratt ? Are you willing to answer same ?
A. Yes.

Q. How long have you known him ? And how did you meet him ?
A. It was early summer, myself and another boy were making a purchase from an Ice cream truck in our neighborhood, and he asked us if we were interested in scouting.

Q. After you got to know him, did you ever go to his house ?
A. Yes, and after I got to know him, I was there quite often.

Q. Was he your scout master ?
A. Yes he was.

Q. Did he ever make advances to you, or talk any thing about sex ?
A. Yes he did, and at times he would talk about a photo of girls. he also spoke of a girl he met in France.

Q. What did he do in making advances to you?
A. He would grab me by my privates.

Q. Did this happen often ?
A. Yes it did, on many occasions, or when ever he would get the chance.

Q. Will you tell me about the over night bus trip ?
A. Yes.

Q. We were going on a over night camping trip. There was [REDACTED], [REDACTED], myself and Mr. Pratt. A suggestion was made that some beer be bought. Mr. Pratt said yes, and he went in to the Hub on Main st. Toms River and purchased three six packs. Some was drank on the way down and the rest was drank at the camp site.

Q. Did he ever buy any other beer at any other time ?
A. No.

Q. Did you ever see a statue in his house ?
A. Yes it was a nude man in a reclining position.

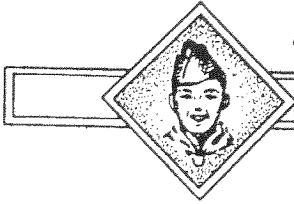


Dear Basil:

Another bit of unpleasantness. On October 11th, William R. Pratt, Scoutmaster of Troop No. 50 sponsored by the Toms River Elks Club was picked up by the Dover Township Police, Toms River, on a homosexual charge. He spent the night in the county jail.

On the morning of October 12th I was alerted and contacted the Police Department. I learned that the charges have been substantiated by affidavits. Later the same day I was advised that additional charges, including sodomy, were preferred. Bail reached \$11,500 on the three charges and Mr. Pratt being unable to raise same was recommitted to jail.

I contacted Mr. Pratt and the Police Department and I am afraid that the charges will stick. Mr. Pratt was formerly registered in Troop No. 20 at Asbury Park and came to us early this year. At the time I questioned Monmouth officials but nothing tangible could be pinned on this man. At the time of registration I voiced my opinion to the Exalted Ruler who is now chairman of the committee, and, obviously, this man must be "red flagged" regardless of the outcome.
